## NOTICE OF PUBLIC HEARING

# TO: Property Owner of Record; Tenant in Possession of Property; and All Parcels Within the Mojave Public Utility District that Receive Service and those in Wonder Acres that Receive Service FROM: Mojave Public Utility District DATE: July 26, 2018

**NOTICE IS HEREBY GIVEN** that on the **11<sup>th</sup> day of October**, **2018 at 6:30 PM** in the Board Room located at 15844 õKö Street, Mojave, CA 93501, the Mojave Public Utility District (District) will conduct a public hearing on the proposal to adjust and increase its water and sewer rates, charges, and other fees. At said time, the District will hear and consider all objections and protests, if any, to said adjustments.

The proposed changes are not new fees, charges, or rates, but rather a proposed increase to existing fees, charges, and other rates. The changes proposed will affect both current and future customers of the District, and thus could possibly affect all property within the Districtø boundaries.

#### Water Rates:

The Districtøs current water rate structure consists of three components: 1. Meter Charge, 2. Usage Fee, and 3. Surcharge Fee. The Meter Charge component is a minimum monthly charge to each water customer and is a fixed amount regardless of how much water a customer uses. Usage Fees and Surcharge Fees are charged to a customer based on the amount of water they use during a billing period. Revenues from Usage Fees and Surcharge Fees generally fund the Districtøs variable operation and maintenance costs and replacement costs; whereas, Meter Charges generally fund the Districtøs fixed operations and maintenance administrative costs. Additionally, the District has assigned a separate meter rate for the õWonder Acresö development; õCache Creek service areaö; õHomestead Metersö; and õCal Windö wind farm which are provided water through means other than the Districtøs main distribution system or outside the District boundaries and thus have additional service costs.

#### Sewer Rates:

The Districtøs sewer rate structure consists of a Monthly User Charge which is dependent on the type of customer classification. The District currently has about 21 different customer classifications for the various residential, commercial, and industrial users within the District. The customer classifications are based on the unique burden each classification places on the Districtøs sewer system compared to a single-family dwelling. Additionally, the District has distinct rate and methodology for the Mojave Air and Spaceport pursuant to an agreement to provide sewer services outside of the District service area.

The Districtøs Board of Directors has proposed the increase in water and sewer service rates as detailed in the rate schedules below. The proposed increase in water service rates is equal to an approximately 15% increase for 2019/2020 and an average increase of 6.25% in each of the following 4 years. The specific proposed increase to water service rates is detailed in the schedule below. Proposed increase in Sewer Service Rates is equal to an approximately 3% increase for 2019/2020 and an average increase of 4.6% in each of the following 4 years. The specific proposed increase to sewer service rates is detailed in the schedule below.

The reason for the proposed increase in water and sewer service rates is due to the increasing cost of providing water and sewer services and necessary capital improvements. These changes and suggested increases are based upon the findings of the Water Rate Study and Sewer Rate Study, each completed by AECOM, the Districtøs independent engineering consultant. A complete copy of the Water Rate Study and Sewer Rate Study, describing the proposed changes to the charges, fees, and rates, and basis for such, is available for review in the office of the District. This study recommended that the District make the proposed changes to ensure adjustments necessary to keep up with the expenses in providing quality water and sewer services.

Assuming the proposed changes are approved, the effective dates of the changes are as follows:

Charge / Fee / Rate	Effective Date
- Water Service Rate	March 1, 2019
- Sewer Service Rate	March 1, 2019

Mojave Air and Spaceport is billed based on actual flows, BOD and TSS concentrations.

Two consecutive days of composite BOD and TSS samples will be taken once per month to include all days of the week to calculate a true average. Samples will be reviewed on an annual basis and adjustments to the pricing structure will be made accordingly. If the average BOD and TSS is higher or lower than 125 mg/L and 220 mg/L, respectively, the pricing in the above calculator shall be adjusted accordingly.
